1. Prepared by the Nominating Committee, the form will aid in the selection of qualified candidates for offices of the California State Society. Please fill in all information to give the fullest description of yourself. All pertinent information will be checked against the records of the State and National Society. You may prepare this form electronically; however, it must be signed and returned via mail or e-mail. If needed you can photograph and send the picture of the signed page with the other Nomination Documents.
2. **Know what is expected of you and of the office you hope to run for:**

The California State Society follows the Bylaws set forth by the National Society.

N.S.C.A.R. Bylaws, ARTICLE IX: Duties of State Officers.

Section 1. All State Officers are expected to conduct themselves in a respectful, honorable, considerate and conscientious manner at all times. The State Officers, as the leaders of the State Society, are the role models from which the younger members learn. A State Officer must be a positive example for all members to admire and emulate. All State Officers shall perform the duties appropriate to the office, assist the respective Senior State Officer and read the joint report, approved and signed by the respective Senior State Officer, at the State Conference. Other duties may be assigned by the State President, the Senior State President and the respective Senior State Officer.

Read the N.S.C.A.R. Bylaws, revised April, 2018, Article IX in order to understand fully the duties of each State Office (pages 10-12), and Article VIII of the California State Bylaws.

3. **THE FORM MUST BE SIGNED BY THE MEMBER SEEKING OFFICE.**
4. Completion of this form does not obligate the Committee to nominate you; however, members submitting this form have an advantage over those who do not. Members not nominated by the Committee are eligible to run from the floor (N.S.C.A.R. Bylaws, revised April 2018, Article VI, Section 5 [Page 5]), provided that they also fulfill Article VI, Section 7 of the California State Bylaws.
